# FINANCIAL FACT SHEET - RETIREMENT VILLAGES

Southern Cross Care (TAS) incorporating Mary's Grange is a Non for Profit Organisation and is governed by a voluntary Board.

- Operated under *Retirement Villages Act 2004 (Tas)*
- Units are available for rent or purchase of a lifetime licence

### Purchase of a Lifetime Licence (Terms & Conditions)

- Payment of a lump sum that is representative of the market value of the unit
- Deductions are made from the lump sum totalling 40% over 10 years, or 5% per annum for the first 5 years and 3% per annum for the next 5 years. (Deferred Management Fee or DMF)
- The resident makes regular payments to Southern Cross Care for Maintenance and Services fees for the upkeep and running units of the village (Maintenance and Service Fee)
- Each resident pays for their own electricity, gas and telephone charges
- Resident receive a 50% share of Capital Appreciation on Unit on departure

## **<u>Other Services</u>** (note all services are not available at every village)

• Bowls (indoor & Outdoor), tennis, gymnasium, craft facilities, library, swimming pool, hair salon, community centre, chapel, 24-hour emergency call bell system, Health and Wellbeing education. etc.

Referral services for appropriate home care and support services

#### <u>Financials</u>

Maintenance and Services Fees

- Vary between sites \$71.05 to \$116.90 per week
- Plus, proportionate share of rates where charged by Municipal Council

Example - Repayment to residents upon departure

Assume Cost of Unit

\$450,000

• Resident in occupancy, 10 years' plus

•	Unit value when resident leaves (estimate)	\$650,000

Calculation of refund to Resident upon departure

•	Ingoing Lump Sum Amount	\$450,000
•	Less deferred Management Fee 40%	\$180,000
•	Plus, capital appreciation 50% i.e. 650,000-450,000	\$100,000
Estimated	\$370,000	

#### <u>Note</u>

- 1. For most villages Services and Maintenance Costs are established by Southern Cross Care on an annual basis
- 2. Deferred Management fees are spread over a longer term compared to other providers i.e. 10 years
- 3. Most extensive provision of other services than any other provider
- 4. Only approved Aged Care Provider in Tasmania to share Capital Appreciation
- 5. Departure refurbishment costs absorbed by Southern Cross Care
- 6. Resale of unit on departure is undertaken by Southern Cross Care, therefore no selling fees are incurred.
