### Update from the CEO,

## **Esteban Cox**

Time is just flying; it seems like only yesterday that I was writing the CEO update for March!

I hope you all had a great and safe Easter Break.

Plenty is happening as we move into a busy time with so many projects happening. To highlight just a few:



- 1. Ongoing culture transformation project. The executive met for a whole day to discuss roles and responsibilities to provide clarity on centralised and decentralised (site-specific) services. It was very productive and enlightening. Following the executive workshop, we are planning a 2-day workshop during first week in May with the broader leadership team. Looking forward to it.
- 2. Budget is upon us, and the management team continues to be busy with the new financial year budget round. As mentioned before, it is challenging setting budgets while taking into consideration the challenges that the age care sector is facing with so many regulatory changes.
- 3. I continue to engage with key stakeholders and employees.
- 4. We are advancing with the voluntary enforceable undertaking with the ACQSC. The project is moving ahead very well. We are on track to meet the next milestone, which is to submit our Action Plans by the end of April.

I would like to share with you great news about the successful re-accreditation of Rosary Gardens. The report stated, "quality care and services are provided knowledgeable, capable, and caring staff.... Residents provided positive feedback across all levels of care and said [they] are happy living at [the facility] and are well

The former Mary's Grange Nursing Home has been closed since 2021 and Southern Cross Care has considered different strategies for the site. In the end, we have decided to sell it.

Since the last resident moved out, the empty buildings have been targeted by senseless illegal entry and vandalism. This has negatively impacted the community, especially those who live close by on Grange Avenue, and caused ongoing security issues and cost.

# In the press for the right reasons

This good news story is extracted from The Advocate, 9 April 2024. By Jess Flint

"If you'd asked Laney Summers last year if she would ever move into Somerset's Yaraandoo aged care facility, she would have been appalled by the thought....she said she would now be the first in line for a room at the centre. "Since [new facility manager] Charmaine Knight has been there, everything has changed for the best," she said. Ms Summers said she thinks people should "get in there while they can" because once word gets out about the changes there might be a waiting list.

Asked what went wrong, CEO Esteban Cox said he believes years of poor leadership

had brough the facility to breaking point....Mr Cox said that Yaraandoo's declining reputation caused difficulties for both its financial position and its ability to recruit and retain care staff. "We still have challenges ahead of us still and we're trying to improve."

...Ms Summers and her friend Joy Mott said they have already witnessed improvements at Yaraandoo under the management of Ms Knight. They said new chef Dilshan Fernandopulle had done a lot in improving the quality of the food served at the centre and the new leisure and lifestyle staff had brought life back to the centre in the form of activities and outings."

# Aged Care Act Delayed

The new Aged Care Act is now expected in January 2025, after being delayed for the federal government to take more time for feedback on its draft form.

The Royal Commission into Aged Care Quality and Safety found the current act and its related laws dating back to 1997 are "no longer fit for purpose".

The new Act will put older people who need aged care at the centre of the system.

It will outline the rights of older people considering and already using aged care services, and ensure the right services are given.

#### Voluntary Enforceable Undertaking on track

In the Timeline of our agreement with the Aged Care Quality and Safety Commission, the Action Plans are due at the end of April 2024.

We are proud to report that this target is on track.

# Culture Identity Framework

The leadership group meeting is not about making decisions behind closed doors. It's about creating better and clearer processes to improve the ways of working together. Our new culture framework is a promise that any people directly affected by any proposed future changes or improvements will be consulted for their input before anything is finalised.

We thank everyone in the organisation for supporting the business leaders to attend this meeting.



# **New Strengthened Aged Care Quality Standards**

With the commencement of the new Aged Care Act, strengthened Quality Standards are expected to be introduced. The existing Standards will remain in effect until then.

We are sharing these draft standards because they will form part of the framework of our client experience strategy, and how we are focusing on the future as we improve our operations.



In 2021, the Royal Commission into Aged Care Quality and Safety recommended that the Department of Health and Aged Care (the Department) review the Standards.

They recommended that the reviewed Standards include vital areas such as:

- food and nutrition
- dementia
- diversity
- governance
- · clinical care.

After a long process of consultation, review and revision, The Department has released the final drafted strengthened Aged Care Quality Standards, seen to the right.

Please note these draft strengthened Quality Standards are not yet in operation.

#### Yaraandoo


Yaraandoo had lots of exciting and different things happening for Easter.

There was also a fun activity for residents to make vases filled with easter decorations for their tables over Easter.












### Glenara Lakes

# Community Garden sows connections





Ainslie residents have been spending time with Port Dalrymple students in the Low Head Community Garden on Tuesday afternoons. On the first week, students interviewed the residents then walked around the garden learning to identify flowers, vegies, herbs and fruit. They wrote a recipe using one of the vegies.

The next week the students worked together to create a posy of dried flowers which were presented to the residents and are now proudly sitting in their rooms at the residential care home.

They've spent time getting to know each other, listening to music from the 1950's, and sharing stories of how life has changed since their own childhoods.

Flanders Poppies week was an opportunity for residents to speak of their memories, and the teenagers their impressions of war. They sowed poppy seeds in dedicated strips and are planning to return near Remembrance Day to pick the poppies for businesses and shops in the local area.





Bringing together the younger and older generations for these activities nurtures understanding, respect, and connection to our community. The children who regularly mix with older people see improvements to their language development, reading and social skills and the residents are less likely to suffer loneliness and isolation.

#### Work Health and Safety

#### **Near Misses**

Reporting a near miss today can prevent an accident from happening tomorrow.



The Aged Care Quality and Safety Commission defines a near miss as when "an occurrence, event or omission happens that does not result in harm (such as injury, illness or damage to health) to a consumer or another person but had potential to do so".

An example would be a person tripping over a floor mat with a rolled-up corner, and almost falling.

At Southern Cross Care we encourage reporting near misses. It gives us the opportunity to assess and learn from such events and prevent future incidents from occurring. For example, if we report someone nearly falling due to a floor mat with a rolled-up corner, we can then implement measures to prevent the next person from falling and possibly being injured. In this case the mat would be removed or replaced.

#### **Case study**

While visiting his father in residential aged care, his son noticed that the packaging colour of the insulin medication the Registered Nurse was about to give his father was not same colour as usual. On mentioning this difference in colour, the Registered Nurse realised that it was not the correct insulin medication prescribed for the resident.

The Registered Nurse recognised that this event was a near miss and that it must be recorded to enable assessment, investigation and/or analysis. Systemic changes to improve practice and to prevent a similar event from happening in future were implemented, and the changes were discussed with the resident and his family.

#### **Reporting Near Misses**

It is essential to report near misses when they are recognised to ensure we keep our colleagues and clients safe, and to reinforce a strong safety culture here at Southern Cross Care Tasmania.
